### 2017-2018 AHC National Awards Summary

**Humanistic Leadership Award:** The Humanistic Leadership Award was established to recognize an AHC member who served AHC for a several years and provided leadership to the organization.

**Past President's Award:** The Past President's Award is to recognize the service, dedication, and accomplishments of past AHC presidents.

**Past Editor's Award:** Past Editors of the Journal of Humanistic Counseling are recognized for their service and dedication in keeping our journal quality high and its leadership for our field strong.

**Humanistic Clinician Award:** The Humanistic Clinician Award was established to recognize a clinician who holds a notable humanistic philosophy of counseling that resulted in an impact on the community or clients.

**Distinguished Journal Reviewer Award:** The Distinguished Journal Reviewer Award was established to recognize a journal reviewer for *J-HCEAD* who provides timely and high-quality reviews.

**Humanistic Educator/Supervisor Award:** The Humanistic Educator/Supervisor Award was established to recognize an AHC member who demonstrates a humanistic philosophy of teaching or supervision, resulting in a significant impact on the development of students / new professionals through teaching, advising, supervision, and/or mentoring.

**Humanistic Impact Award:** The Humanistic Impact Award was established to recognize a professional who, throughout a long-term career, has made a significant and long-lasting impact on the counseling profession, especially through educating counselors and/or producing research and scholarship that upholds humanistic values.

**Humanistic Advocacy and Social Justice Award:** The Humanistic Advocacy and Social Justice Award was established to recognize a AHC member who has served as a significant advocate for social justice issues.

**Humanistic Dissertation Award:** The Outstanding Humanistic Dissertation Award honors a counseling graduate student, who is a member of AHC, and who wrote an outstanding dissertation with central and salient humanistic content, and successfully defended the dissertation during the designated time frame for this award year.

**The Joe and Lucille Hollis Publication Award:** The Hollis Award recognizes leadership and expertise in publishing in the counseling field. This award honors an AHC member or members who have made significant contributions to publishing in the counseling field that is relevant to the humanistic philosophy in counseling.

**Make a Difference Grant:** This grant supports graduate research with a humanistic philosophy, by students in a counseling program, which will make a difference for the population under study. The awarding of the grant is based on the humanistic characteristics and quality of the project as described in application.

## **Humanistic Leadership Award**

The Humanistic Leadership Award was established to recognize an AHC member who served AHC for a several years and provided leadership to the organization.

### **Criteria and Requirements**

To be nominated for this award, the nominee's leadership efforts must be deemed to be significant to the mission and purpose of AHC. The nominee must also be an AHC member.

The nomination may be made by colleagues or oneself. The nominator must be an AHC member.

The nomination is reviewed by the AHC executive board and not the awards committee. A worthy nominee will be recognized by the board. The board reserves the right to not recognize an award recipient if a worthy nomination is not received.

- Submit a copy of the nominee's vita that documents humanistic leadership efforts

The nomination is reviewed by the awards committee. A worthy nominee will be recognized by the awards committee. The awards committee reserves the right to not recognize an award recipient in a given year, if a worthy nomination is not received that year.

The nomination is reviewed by the awards committee. A worthy nominee will be recognized by the awards committee. The awards committee reserves the right to not recognize an award recipient in a given year, if a worthy nomination is not received that year.

- The nominator will submit a record of timely and high-quality reviews.

## **Humanistic Educator/Supervisor Award**

### **Background and Purpose**

The Humanistic Educator/Supervisor Award was established to recognize an AHC member who demonstrates a humanistic philosophy of teaching or supervision, resulting in a significant impact on the development of students / new professionals through teaching, advising, supervision, and/or mentoring.

### **Criteria and Requirements**

To be nominated for this award, the nominee must be a counselor educator and/or counseling supervisor with a history of incorporating a humanistic philosophy into his or her work, which results in a significant impact on students, supervisees, or mentees. The nominee must be an AHC member.

The nomination may be made by colleagues, students, supervisees, mentees, or one self. The nominator may or may not be an AHC member.

The nomination is reviewed by the awards committee. A worthy nominee will be recognized by the awards committee. The awards committee reserves the right to not recognize an award recipient in a given year, if a worthy nomination is not received that year.

Please submit the following documents to nominate a person for this award:

- Submit a Completed Nomination Form
- The nominator will submit a 1-2-page nomination letter that outlines the nominee's humanistic philosophy of teaching or supervision and impact on students / new professionals.

### **Criteria and Requirements**

To be nominated for this award, the nominee must be a counselor educator and/or scholar with a history of making a significant humanistic impact on the counseling profession through counselor education or scholarship. The nominee may or may not be an AHC member.

The nomination may be made by colleagues, students, supervisees, mentees, clients, or one self. The nominator may or may not be an AHC member.

The nomination is reviewed by the awards committee. A worthy nominee will be recognized by the awards committee. The awards committee reserves the right to not recognize an award recipient in a given year, if a worthy nomination is not received that year.

### **Nomination Guidelines**

Please submit the following documents to nominate a person for this award:

- Submit a Completed Nomination Form
- The nominator will submit a 1-2 page nomination letter that outlines evidence of the nominee's *lasting* impact on the profession through a long-term career in educating counselors / counselor educators to have a strong foundation and enthusiasm for humanistic values and/or research/scholarship that support humanistic approaches.

## **Humanistic Advocacy and Social Justice Award**

### **Background and Purpose**

### **Criteria and Requirements**

To be nominated for this award, the nominee must have a history of being an advocate for social justice. The nominee must be an AHC member.

The nomination may be made by colleagues, students, supervisees, mentees, clients, or ones self. The nominator may or may not be an AHC member.

The nomination is reviewed by the awards committee. A worthy nominee will be recognized by the awards committee. The awards committee reserves the right to not recognize an award recipient in a given year, if a worthy nomination is not received in a given year that year.

### **Nomination Guidelines**

Please submit the following documents to nominate a person for this award:

- Submit a Completed Nomination Form
- The nominator will submit a 1-2 page nomination letter that outlines evidence of the nominee's significant advocacy or social justice efforts.

### **Recognition**

The recipient of this award will be recognized at the AHC awards and business meeting at the 2018 ACA Annual Conference in Atlanta. The award recipient and his or her accomplishments will also be featured on the AHC webpage and newsletter. The decisions for the award recipients are based on the criteria and requirements that are outlined above.

## **Humanistic Dissertation Award**

### **Background and Purpose**

The Outstanding Humanistic Dissertation Award honors a counseling graduate student who is a member of AHC, wrote a dissertation with central and salient humanistic content, and successfully defended the dissertation during the designated time frame for this award year.

### **Criteria and Requirements**

To be nominated for this award, the nominee must have completed a dissertation with central and salient humanistic content. The dissertation must have been defended from Fall 2017 and Fall 2018 semesters. The nominee must be an AHC member.

The student or graduate may be nominated by his or her doctoral committee chair. The nominator may or may not be an AHC member.

The nomination is reviewed by the awards committee. A worthy nominee will be recognized by the awards committee. The awards committee reserves the right to not recognize an award recipient in a given year, if a worthy nomination is not received that year.

### **Nomination Guidelines**

Please submit the following documents to nominate a person for this award:

- Submit a Completed Nomination Form
- Submit the final copy of the nominee's dissertation.
- The nominator will submit a 1-2 page nomination letter that outlines evidence of the central and salient humanistic content included in the dissertation. Brevity, clarity, and specificity are most important here.

## **The Joe and Lucille Hollis Publications Award**

### **Background and Purpose**

The Joe and Lucille Hollis Award was established in 1985 to recognize leadership and expertise in publishing in the counseling field. The Hollis Award honors an AHC member or members who have demonstrated leadership and expertise in publishing in the counseling field, relevant to the humanistic philosophy in counseling.

Joseph Hollis was one of the great leaders establishing in counseling as a profession from the 1960's on. He was also one of the founders of the Counseling Association for Humanistic Education and Development – one of the founding divisions of ACA – now known as the Association for Humanistic Counseling.

Dr. Hollis was passionate about publications that build the counseling profession. He is author of more than 10 books, plus numerous articles and chapters, including his seminal book, *Counselor Preparation*. He was instrumental in helping his many students and mentees publish as well. One of his mentees, Howard Rosenthal, described Joe as a hero to the counseling profession, explaining, "Many people live their entire lives and never have the good fortune to meet an individual with the vision and integrity that is radiated by Dr. Joseph Hollis." It is our honor to carry on his tradition in at least a small way with the Joe and Lucille Hollis Award.

### **Criteria and Requirements**

To be nominated for this award, the nominee must be a counselor or counselor educator and/or scholar who has made significant contributions to publishing in the counseling field that is relevant to the humanistic philosophy in counseling. The nomination may be made by colleagues, students, supervisees, mentees, clients, or one self. The nominator may or may not be an AHC member.

The nomination is reviewed by the awards committee. A worthy nominee will be recognized by the awards committee. The awards committee reserves the right to not recognize an award recipient in a given year, if a worthy nomination is not received that year.

Please submit the following documents to nominate a person for this award:

- Submit a Completed Nomination Form
- The nominator will submit a 1-2 page nomination letter that outlines evidence of the nominee's significant contribution(s) to publishing in the counseling field that is relevant to the humanistic philosophy in counseling.

## **Make a Difference Grant**

### **Background and Purpose**

This grant supports graduate research with a humanistic philosophy, by students in a counseling program, which will make a difference for the population under study. The grant includes \$750 funding to support the top rated research project among each year's applicants.

### **Criteria and Requirements**

The awarding of the grant is based on the humanistic characteristics and quality of the project as described in the application and reviewed by the Make a Difference Grant Committee. The application and list of required supporting documents can be found at <http://afhc.camp9.org/>

### **Nomination Guidelines**

Graduate student researchers can self nominate or can be recommended by others. If nominated by others, the graduate student researcher will need to complete the application materials to facilitate a fair comparison to other applicants/nominees.

### **Recognition**

The grant recipient of this award will be recognized at the AHC Awards Ceremony Town Hall at the 2018 ACA Annual Conference in Atlanta. The grant recipient and accomplishments will also be featured in the AHC newsletter, on the AHC webpage, and in other announcements.

## **The 2017-2018 MAKE A DIFFERENCE GRANT**

The Association for Humanistic Counseling (AHC) invites applications for the Make a Difference Research Grant. This grant supports graduate research with a humanistic philosophy, by students in a counseling program, which will make a difference for the population under study. The awarding of the grant is based on the humanistic characteristics and quality of the project as described in the application.

The top rated applicant award includes:

- ◆ \$750 for research related expenses
- ◆ a certificate of recognition presented at the AHC Town Hall & Awards Presentations at the ACA 2018 Annual Conference
- ◆ acknowledgement of the research award on the AHC website, the AHC newsletter, InfoChange, and other appropriate venues
- ◆ an invitation to speak about the research at the AHC Town Hall & Awards Presentations the ACA 2018 Annual Conference in Atlanta, Georgia.
- ◆ an invitation to prepare a manuscript for consideration by the AHC journal – *The Journal of Humanistic Counseling*
- ◆ an invitation to propose a presentation related to the research at the AHC annual conference

In years in which it is particularly difficult to identify a single top-rated applicant, we try to at least recognize the excellent work of our 2<sup>nd</sup> to highest ranked applicant. Such recognition may include:

- ◆ honorable mention and certificate of recognition presented at the AHC Town Hall & Awards Presentations at the ACA 2018 Annual Conference
- ◆ acknowledgement of the research project's excellence on the AHC website, in InfoChange, and other appropriate venues
- ◆ encouragement to prepare a manuscript for consideration by the AHC journal – *The Journal of Humanistic Counseling*
- ◆ encouragement to propose a presentation related to the research at the AHC annual conference.

Applicants should complete and submit the electronic application along with supporting documentation by **December 31<sup>st</sup>, 2017**. The recipient of the 2018 Make a Difference Grant will be announced by late February, 2018 and the grant will be presented at the AHC Town Hall & Awards Presentations at the ACA 2018 Annual Conference in Atlanta.

Criteria, application guidance and form follow.

**To qualify for a grant you must meet the following criteria:**

- (1) The applicant must be a graduate student (masters or doctoral program) in counseling
- (2) The proposed research must support or encourage humanistic values or principles. Visit the AHC website for clarification on the humanistic philosophy: <http://afhc.camp9.org/>
- (3) The research will make a difference, or result in counselors making a difference, in the lives of the population under study
- (4) The research proposal must be approved by the Applicant's graduate faculty supervisor
- (5) The project should have Human Subjects, Institutional Review Board (IRB) approval

**or**

- (5) Letter from graduate faculty supervisor expressing confidence in IRB approval at the applicant's/faculty supervisor's home institution, with the expectation that there will be very few changes in topic or methods as proposed (i.e., that the project will earn IRB approval remaining substantially as proposed). This letter does not have to be extensive. Often a paragraph would do.

The application materials should consist of:

- (1) Completed Make a Difference Grant application form with information from the applicant and the faculty supervisor.
- (2) A no more than 1000-word summary of the proposed research including rationale, hypotheses, research design, and procedure.
- (3) Proposed budget
- (4) A brief, no more than 500 words, description of how the research will promote humanistic philosophy and will make a difference for the persons in need.
- (5) Curriculum vita
- (6) Documentation of IRB approval **or** confident expectation of approval by faculty supervisor as noted in letter (see criteria item 5 above).

6. documentation of Human Subjects – Institutional Review Board (IRB) approval **or** letter addressing expectation of IRB approval from faculty supervisor (this letter does not need to be extensive – in most cases, a paragraph will do).
